A leading worldwide provider of commercial filtration systems and replacement parts, this long-standing technology-driven company has remained committed to satisfying customer needs for filtration solutions through research and development since its founding nearly 100 years ago. Their focus markets include Industrial and Engine, Power Generation, Air Purification, and Off-Road Equipment and Vehicles.

The Challenge

The integration of process development and systems is essential to maintaining compliance with the EPA and other government regulations. To be in compliance, the client needed a robust solution to:

- ▲ Avoid costly compliance-related fines of \$500,000 per incident
- ▲ Reduce warranty fraud and legal fees
- ▲ Increase productivity, accuracy and efficiency through a data management role that utilizes process and system development

In order to achieve these objectives, the client was in need of a new system/application to interface with their Data Warehouse, ERP, web and other source data points. At the time, one person was responsible for tracking all compliance and warranty data on all of the client's customers. This manual process of data-log collection and analysis was very slow and inaccurate. In addition, the audit trail and support information was not sufficient enough to be compliant with regulators.

The client's vision was to shift responsibility of product use and misuse back onto their Dealers (customers) by linking warranty eligibility to compliance. They wanted to require that their Dealers provide a data log prior to purchase and prior to warranty registration.
